## INFORMATION

for the filling out of application form K07 certifying taxation under general arrangements for business taxation

**According to Council Directive 2003/48/EC on taxation of savings income in the form of interest payments** (hereinafter: Directive) the **certificate** is issued by the state tax authority acting within its competence based on the data contained in its registers, with a content corresponding to data available on the data of issue if the taxpayer declares that the necessity to issue the certificate is very likely.

According to the provisions of the Directive the state tax authority issues the certificate in Hungarian and English language. The tax authority also issues the certificate using the form established by a foreign tax authority if the claimant attaches its certified Hungarian translation.

According to the Directive the **deadline for the issue** of the certificate is 2 months.

We ask you to indicate the **number of** the requested **copies** using Arabic numerals.

We ask you to indicate with the corresponding code whether you wish the **issue** of the certificate with **postal delivery** (1) or with **personal receipt** (2). We ask you to indicate your postal address if you wish to get the certificate by post; your phone if you wish to receive it in person.

If the claimant does not act itself in the matter concerning the issue of the certificate then the attachment of an ad hoc authorisation must be attached to the form, or please indicate in the corresponding box that he/she has a permanent authorisation, or certify by any means that he/she has agency; we also ask to indicate the name of the **representative** or **agent** for the receipt.

The issue of the certification is **duty free**.
